This institution uses Dr. APJ Abdul Kalam Technical University prescribed Plagiarism software (Turnitin) to ensure that documents submitted by students, faculty members and staff are free of plagiarism. Every student submitting a thesis, dissertation, or any other such documents shall submit an undertaking indicating that the document has been prepared by him or her and that the document is his/her original work and free of any plagiarism. Every faculty member submitting a research paper, chapters in books, full-fledged books and any other similar documents shall submit an undertaking indicating that the document has been prepared by him or her and that the document is his/her original work and free of any plagiarism. The anti-plagiarism software facility is extended to the students and faculty members involved in research work leading to submission of Masters thesis and/or submission of research paper for publication in journal/conference. The students of M.Pharm are required to done their plagiarism check from third party and submit the generated summary and detailed report alongwith the certificate in the college.

CODE OF RESEARCH ETHICS:


This code expresses ethical values of all staff engaged in Academic and Research activities at the Institute, who have committed themselves to:
